FACULTIES

12 September 2012	St Matthew's Parish, Hastings – To sell the current vicarage at 1002 Gordon Road, Hastings with the intention of replacing it with a property that conforms to Diocesan standards.
15 October 2012	Mount Maunganui Parish - The construction of a separate area in St Mary's Family Centre for the provision of children's meals and extend the existing kitchen. The cost of the work is estimated at \$106,000 GST inclusive to be paid from reserve funds held in the Waiaapu Board of Diocesan Trustees Investment Account.
15 October 2012	Holy Trinity Tauranga Parish – The purchase and installation of a Johannus T370 organ in the church. The cost is estimated at \$49,000 GST inclusive to be paid by Parish fundraising and donations.
29 October 2012.	St John's Parish, Otumoetai – The subdivision of the vicarage site at 16 Seaview Road, Otumoetai. Specific costs not available at present but will be within the income to be realised by the ultimate sale. The proposal was passed at a special meeting of the Parish on 27 th May, 2012.
31 October 2012	St John's Parish, Otumoetai – The removal in the Church of St John's, Otumoetai of the current altar rails, raise the second level of the sanctuary to one complete level using the wood from the current altar rails and remodelling into removable rails. The cost of the work is estimated at not more than \$5,500 to be paid initially through an approved overdraft from the Diocese and managed as giving and income increase.
20 December 2012	Waikohu Co-operating Church – The placement in the nave of St John's Church, Te Karaka of the Maori carving gifted by Phyllis Callaghan of Ihu Karaiti (Jesus). No cost is involved.
4 February 2013	Hiona St Stephen, Opotiki – To build a Counselling Room in the Hiona St Stephen's Parish (rear hall). The cost of the work is estimated at \$8,000 to be paid by a grant from Southern Trust.
29 April 2013	St Andrew's Parish, Westshore, Napier – The installation of a stained glass window in memory of Reverend Winsome McConnochie, in the south wall of St Andrew's Church, Westshore. The cost of the work is estimated at approximately \$2,400 paid by the family and vestry paid \$817.00 for safety glass.
29 April, 2013	Waiaapu Cathedral Parish of St John the Evangelist, Napier – To proceed with the first stage of the signage project, which includes the noticeboard in the main entrance and the signage on the two entrance pillars. The cost of the first stage is \$2,300, \$2,000 of which comes from the Cathedral Link's Fund and the balance covered by parish funds as resolved at the Vestry meeting held on the 27 th March, 2013.

- 27 June 2013 **St John's Parish, Otumoetai** – To proceed with the sale of the Vicarage and land at 16 Seaview Road, Otumoetai. The cost of the work will be according to the costs of putting the sale in the hands of real estate agents and this work will be undertaken in partnership between the Diocese and the Vestry of St John's Parish. The Vestry approved the sale unanimously at its meeting held on the 5th June, 2013.
- 4 July 2013 **Waiapu Cathedral Parish of St John the Evangelist, Napier** – To erect a plaque for Dean Joseph Brocklehurst (and later Kate Williams) to complete the earthquake memorial panel in the Heritage Hallway. The cost of the work is estimated at \$760 and will be paid by a donation from his granddaughter. The plaque to read:
- 'Joseph Brocklehurst
1877 – 1957
- Who led this Cathedral and Diocese
Through Earthquake, Fire and Wartime*
- Dean 1929 – 1944
Vicar General 1939 – 1944
Archdeacon 1944 – 1955'*
- 11 July 2013 **Waiapu Cathedral Parish of St John the Evangelist, Napier** – For the installation of a chancel ramp to allow easy access to the Sanctuary, Maori Chapel and Administrative Rooms of the Waiapu Cathedral of St John the Evangelist. The cost of the work is estimated at \$12,986.02 (excl. GST) to be paid from the Keith Dockery bequest as well as donations received.
